The Illinois Health & Hospital Association is located at:

222 South Riverside Plaza. As of November 2016, the front of the building is under construction.

Attendees can also use the 225 South Canal Street entrance. If using the 225 South Canal Street doors, once entering the building proceed up a few small flights of stairs on the left. Continue through the revolving doors to enter the building lobby.

Once in the lobby, attendees will be required to check in at the security desk. **Identification is required.** After being checked in by security, you will be directed to the appropriate elevators to the 19th floor. Upon arrival on the 19th floor you will be directed to the meeting room by the receptionist.
